Dear Mr. Secretary,

Yesterday, December 13, the government of Azerbaijan released 32 of its Armenian hostages, in exchange for Armenia's release of two Azerbaijani soldiers who had been detained after infiltrating sovereign Armenian territory and killing an Armenian civilian. This prisoner exchange was announced last week, after a visit to Baku by Assistant Secretary of State James O'Brien.

We are grateful for the release of these 32 hostages, all of whom were brazenly kidnapped by Azerbaijan *after* Armenia and Azerbaijan agreed to a ceasefire on November 9, 2020, and most of whom had been held captive in Baku for nearly three years.

Nevertheless, the willingness of Azerbaijan to release its abductees, contrary to what State Department spokesperson Matthew Miller stated, is far from "an important confidence building measure." It is, as the Armenian National Committee of America wrote, "a minimal requirement for membership in the family of civilized nations."

As the ANCA warns, "rewarding such actions only encourages Azerbaijan to commit renewed violations, in anticipation of securing additional concessions."

Moreover, even after this prisoner release, many Armenians still languish in Baku's dungeons. The Center for Truth and Justice has identified an additional 20 Armenian hostages being held by Azerbaijan. Siranush Sahakyan, a human rights attorney acting on behalf of the hostages' families, believes there may be as many as 80 more Armenian hostages, both soldiers and civilians.

This means that the hostages Azerbaijan has released represent as little as one-fourth of the Armenians being illegally held by Baku.

Among the twenty known hostages whom Azerbaijan refuses to release are seven civilians that Azerbaijani forces kidnapped from Nagorno Karabakh during the 2020 war, or during Azerbaijan's nine-month blockade.

Azerbaijan is also detaining eight current and former members of the elected government of the Republic of Artsakh. We are not aware of any public calls by U.S. officials for these individuals to be released.

We urge you to publicly call for the release of all Armenians being held hostage by Azerbaijan. This call should be part of a larger program to hold Azerbaijan accountable for its aggression and ethnic cleansing, and ensure the safe return of the people of Nagorno Karabakh to their homeland.
